

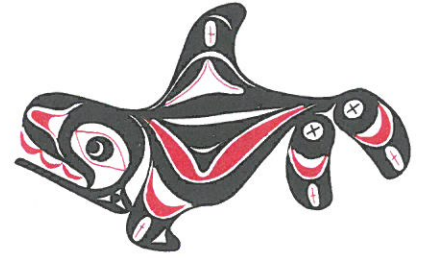

## AHOUSAHT COUNCIL RESOLUTION

### Ahousaht Derelict Vehicles, Appliances, or Structures Bylaw

#### Definitions:

Appliance: any household appliance including washer, dryer, refrigerator, freezer, toaster, television, stereo, or parts from any of these items or similar items

Vehicle: any automobile, truck, motorcycle, bus, boat, ship, floating vessel or similar

Structure: any house, apartment, building, storage shed, or similar

Abandoned: cast aside, deserted, shown no interest in by any person

A vehicle is considered derelict if it is:

- a. not in operational condition AND
- b. wrecked or partly wrecked, rusted or dismantled or partly dismantled AND
- c. not insured and registered under The Province of British Columbia Vehicle Act and does not have a current, valid license plate attached to it AND
- d. left abandoned for more than two weeks

An appliance is considered derelict if it is:

- a. not in operational condition AND
- b. wrecked or partly wrecked, rusted or dismantled or partly dismantled AND
- c. left abandoned for more than two weeks

A structure is considered derelict if it is:

- a. not in operational and/or livable condition AND
- b. wrecked or partly wrecked, burned or partly burned, flooded or partly flooded, infested or partly infested, dismantled or partly dismantled AND
- c. left abandoned for more than four weeks

Notice will be issued in two parts. First by way of a **WARNING** sticker AND second by way of a **REMOVAL** sticker affixed to the vehicle, appliance or structure, in plain visible sight, each dated & signed


accordingly.

A warning sticker will begin the process of determining when the item has exceeded the limits of abandonment, as defined in each part c above.

A removal sticker will begin the process of final notice, which can be appealed up to four more weeks after which the item will be removed or deconstructed.

Vehicles, appliances and other related items will be charged a levy when arriving into Ahousaht for the first time. These levies will be retained and used to offset the cost of removing derelict items from Ahousaht.


